



MEMBERSHIP TERMS & CONDITIONS

By applying for membership or renewing your membership with Blue Gum Park Tennis Club (**the Club**):

1. You agree to be bound by the Club's Constitution, By-Laws and Policies and the By-Laws and Policies of Tennis West and Tennis Australia, which are located at <https://www.tennis.com.au/about-tennis-australia/reports-and-policies/policies>
2. You also agree for the Club to register you in *My Tennis*, a Tennis Australia player data base, by providing your name, date of birth, gender, post code, phone number and email, as required on the Club's membership form.

The Club utilises *My Tennis* for membership database purposes. Club members registered in *My Tennis* have the ability to opt in and out of receiving Tennis communications. **By default, members will only receive communications from the Club.**

The Participant Terms and Conditions as well as Tennis Australia's Privacy Statement regarding *My Tennis* are set out below.

Privacy Statement

To assist us in the provision of products and services, we need to collect personal information about you. When you provide personal information, you agree that this will be used by Tennis Australia and other Australian Tennis Organisations (ATOs) under the terms of this statement, and the tennis privacy policy located at <http://www.tennis.com.au/privacy>, which contains information about how you may access and seek correction of your personal information or complain about a breach of your privacy, and how we will deal with that complaint.

If you do not agree, you must not provide your personal information, and you may be unable to access all of our products and services. Tennis Australia and other ATOs may disclose your personal information to other parties, including our related companies, other ATOs, and third parties who provide us services. From time to time, these third parties may be located (and therefore your personal information may be disclosed) overseas, including to the USA and the Netherlands and as otherwise specified in the tennis privacy policy. Tennis Australia and other ATOs may use and disclose your personal information for direct marketing purposes regarding the products and services you are signing up to receive, unless you opt-out (which you can do at any time in accordance with the tennis privacy policy)
